AHCPGD510 Conduct Comprehensive Inspection of Park Facilities

Course content/overview

This Nationally Recognised training course will provide participants with the skills and knowledge required to conduct a compliance audit of park or recreational facilities to identify non-conformities with Australian Standards, legislative and work health and safety requirements, as well as manufacturers' standards. It applies to individuals who analyse information and exercise judgement to complete a range of advanced skilled activities and demonstrate deep knowledge in a specific technical area. They have accountability for the work of others and analyse, design and communicate solutions to a range of complex problems. All work is carried out to comply with workplace procedures.

Entry requirements

Students are required to hold the unit AHCPGD305/AHCPGD311 – Conduct Operational Inspection of Park Facilities. Evidence of which must be supplied prior/upon enrolment. Participants are required to be over 18 years of age, be in good health and physically fit, and be responsible for their health and safety during the course. Participants are required to wear appropriate PPE. Mandatory completion of a Language Literacy and Numeracy test is also required to determine course suitability.

COURSE MODE

Face-to-face delivery

The course will be delivered through a combination of face-to-face delivery in a classroom setting, followed by practicals within the students' workplace. This course comprises of a combination of theory and practical training followed by a knowledge and skills assessment.

The following schedule is customised to suit to learners who are existing workers within local councils. It is expected that participants will already have completed a comprehensive inspection within their job role. Participants may hold positions such as playground specialists, supervisors or maintenance personnel within local councils seeking qualification to be able to ensure safety and functionality of equipment and facilities in parks and on playgrounds.

These positions require the participants to analyse information and exercise judgment to complete a range of advanced skilled activities and demonstrate deep knowledge in a specific technical area.

They have accountability for the work of others and analyse, design and communicate solutions to a range of complex problems.

A Pre-course questionnaire must be completed prior to the face to face delivery to assess each participant existing knowledge of working within the horticulture industry. RPL can only be offered to students who can provide an extensive portfolio of evidence to support previous knowledge, skills and work experience. Online delivery

The course will be delivered through our online Learning Management System. Students who enrol in this course will have access to our online learning system for 12 months from their enrolment date. It is expected that participants will already have completed a comprehensive inspection within their job role, and meet all entry requirements noted above.

Participants may hold positions in various organisations and industries and should be seeking to ensure the safety and functionality of equipment and facilities in parks and playgrounds. RPL can only be offered to students who can provide an extensive portfolio of evidence to support previous knowledge, skills and work experience. Course content

2. Undertaking comprehensive inspection of park facilities
3. Assessing age and predicting effective lifespan of existing park facilities
4. Submitting reports and recommendations

Delivery and Duration

- 3-day face-to-face delivery - See Delivery Plan below.
- RTO-directed self-paced study of the learner guide will require the student to allow for a minimum of 6 hours prior to the face-to-face delivery. Note this may be varied for each individual learner, dependent on their learning style.
